BUILDING PERMIT AND TINY HOUSE PARK FEES**

A RESOLUTION OF THE CITY OF STANLEY, CUSTER COUNTY, IDAHO, TO ESTABLISH BUILDING PERMIT FEES AND TINY HOUSE PARK FEES WITHIN THE CITY OF STANLEY AND TO ESTABLISH AN EFFECTIVE DATE.

WHEREAS, the Council of the City of Stanley is empowered to establish Building Permit Fees pursuant to section 15.04.060 of the Stanley Municipal Code and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF STANLEY, IDAHO THAT:

1. Building Permit Fees shall be:

- A. \$150.00
  - a) Outbuildings under 250 square feet
  - b) Additions under 250 square feet
  - c) Remodels subject to building permit requirements in 15.04.010 of the Stanley Municipal Code.
  - d) Fences
  - e) Excavation and Fill work
  - f) Road Work
  - g) Sidewalks and Boardwalks
  - h) Decks
  - i) Roofs – Repair or Replacement
- B. \$100.00 Minimum plus \$ .25 per square foot:  
Construction over 250 square feet, not to include new home construction or commercial construction
- C. \$150.00 Minimum plus \$ .50 per square foot:  
New Residential and Commercial construction and additions over 250 Square feet
- D. \$100.00 Tiny House Park Site Plan  
Independent site plan evaluation without construction, such as tiny house parks or mobile home parks
- E. \$500.00 Telecommunication infrastructure, including wireless communication towers and antennas, radio antennas

2. Effective Date:

- A. These fees shall be in effect as of September 7, 2021





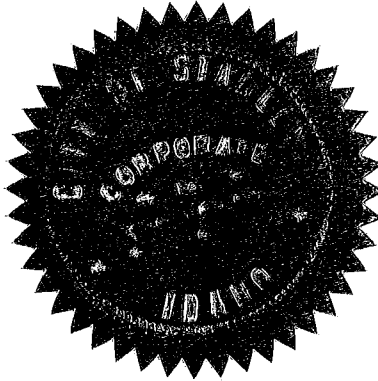
