Stanley-Sawtooth Chamber of Commerce - Option Tax Financial support request - \$6250.00 for the 1<sup>st</sup> Quarter: Council President Gadwa moves to approve the 1<sup>st</sup> quarter financial request by the Chamber of Commerce, Councilmember Clegg seconds. All approve. Motion passes.

Sawtooth Valley Recreation Center Earmark Proposal: This earmark would be for FY2025 through a possible appropriation through Congressman Simpson’s office for \$4,000,000.00, similar to the one the City of Stanley has applied for in 2023 for: The Community Project Funding Request for FY2024. If the Sawtooth Recreation Center was granted such an appropriation they would like to propose a new building site next to the Ice Rink in front of the Chapel: this building would house a kitchen, showers, trash facility, laundry facility and an exercise room. If enough funding was left over, they would also like to propose a small pool facility located on WRLT property in the Valley Creek Preserve; taking advantage of the hot spring currently not being used in this location. Both these facilities would be for local and public use. Council President Gadwa is opposed to seeing any type of trash facility up at Pioneer Park, the trash cans would be full in two days and then there would be trash constantly piled up around the dumpsters, this is not an image we want in our scenic park. Councilmember Cardoso moves to support the rough draft proposal concept. Councilmember Cron seconds. All approve. Motion passes.

Resolution 2023-3 Office Hours and Employee Work Hours: this resolution does not supersede resolution 2021-8. Council President Gadwa moves to approve resolution 2023-3. Councilmember Cardoso seconds. All approve. Motion passes.


